- Be at least 65 years old,
   Have a household income of \$96,000 or less, and

This is not a tax forgiveness program, however, this program: • Limits the maximum amount of property tax paid to 3% of total household income, and

Have a nousehold income of \$90,000 of less
 Have lived in your home for at least 5 years.

## Penalty for Late Payment of Property Tax

If you pay your first half or second half property tax after the due dates, a penalty will be added to your tax. The later you pay, the greater the penalty you will pay. The table below shows the penalty amounts added to your tax if your property taxes are not paid before the date shown. To avoid a penalty, envelopes must be postmarked by the due date to be considered paid on time. First half tax payments must be paid in full with penalty (if applicable) prior to applying money toward second half payment.
