

Senior Citizen Property Tax Deferral

The Senior Citizen Deferral Program provides a low-interest loan to senior citizens having difficulty paying property taxes.

This is not a tax forgiveness program, however, this program:

• Limits the maximum amount of property tax paid to 3% of total household income, and

- Endures the amount of tax paid remains the same as long as you participate in this program.
 - To be eligible, you must file an application by November 1, 2024, as well as:

1. Be at least 65 years old,

- 2. Have a household income of \$96,000 or less, and
- 3. Have lived in your home for at least 5 years.

Penalty for Late Payment of Property Tax

To avoid a penalty, envelopes must be postmarked by the due date to be considered paid on time.
