The Senior Citizen Deferral Program provides a <u>low-interest loan</u> to senior citizens having difficulty paying property taxes.

- This is not a tax forgiveness program, however, this program:

   Limits the maximum amount of property tax paid to 3% of total household income, and • Endures the amount of tax paid remains the same as long as you participate in this program.

  - To be eligible, you must file an application by November 1, 2024, as well as:
- Be at least 65 years old,
- Have a household income of \$96,000 or less, and
- Have lived in your home for at least 5 years.
