The Senior Citizen Deferral Program provides a **low-interest loan** to senior citizens having difficulty paying property taxes.

This is not a tax forgiveness program, however, this program:

• Limits the maximum amount of property tax paid to 3% of total household income, and

• Endures the amount of tax paid remains the same as long as you participate in this program.

To be eligible, you must file an application by **November 1, 2024**, as well as:

- Be at least 65 years old,
- 2. Have a household income of \$96,000 or less, and
- 3. Have lived in your home for at least 5 years. To receive a fact sheet and application for this program, or to file an on-line application, go to www.revenue.state.mn.us and type "deferral" into the search box. You may also call the Senior Deferral Administrator at (651) 556-4803 to have the information mailed to you.

Penalty for Late Payment of Property Tax
